COUNCIL MEETING

January 8, 2025

COUNCIL PRESIDENT CONTIPELLI CALLED CAUCUS TO ORDER at 5:02 p.m.

MAYOR BACCI CALLED ROLL CALL: Bloam, Centa, Contipelli, Schoeffler, Unger, Volek.

Mr. Contipelli asked the council if there were any questions on the agenda. There were none.

Mr. Contipelli also asked council to resume his position as Council President. The mayor asked if there were any other nominees for Council President. There were none. The mayor then asked for a motion to nominate Mr. Contipelli for Council President. Mr. Bloam made the motion to nominate Mr. Contipelli for Council President, seconded by Mr. Centa. All in favor, none opposed.

Mayor Bacci spoke to council about the Charter Review Committee and how last year, the idea of council wanting to change the committee to meet from 4 years to 10 years. Law Director Ben Chojnacki confirmed that council can vote on the change during council meetings.

Mayor Bacci also noted that pool staff will be needed this year as Sandi Sturgill will not be returning as pool manager. If council has any recommendations for that position, please let his office know. During the February council meeting, I will be asking Kelly Hartman to return as Concession Stand Manager.

Mayor Bacci also mentioned that we will be holding our Arbor Day celebration on Friday, April 25 at Bacci Park. Information will be forthcoming in the next newsletter.

And lastly, as council knows, the village has ordered a new fire engine; however, it will not arrive until the spring of 2026.
